### NOTICE OF CDBG PUBLIC HEARING and REGULAR BOARD MEETING

The Village of Pecos, New Mexico, wishes to inform all interested parties that a public hearing will be held on Monday, April 13, 2020, beginning at 6:00 p.m., soon thereafter the Regular Board Meeting will continue at Village of Pecos Municipal Building, 92 South Main, Pecos, NM.

The purpose of this public hearing is to receive public input on community development needs and suggestions for future 2020 CDBG projects. The Community Development Block Grant Program (CDBG) was established under Title I of the Housing and Community Development Act of 1974, as amended, in order to assist communities in providing essential community facilities, in providing decent housing for resident, in promoting economic development and in maintaining a suitable living environment. State and National objectives of the CDBG Program require that assistance be made available for activities that address at least one of the following:

1. An activity identified as principally benefiting persons of low and moderate income.
2. Aid in the prevention and elimination of slum and blight.
3. Meet other community development needs of recent origin having a particular urgency because existing conditions pose a serious and immediate threat to the health and welfare of the community where other financial resources are not available to meet such needs.

Applications are limited to a maximum amount of \$750,000 except for planning applications which have a limit of \$50,000. Eligible activities and categories will be described. All interested parties are invited to attend, submit project ideas, provide supporting data and testimony, and other pertinent information. With sufficient notice, a translator will be provided for non-English speaking residents. Those unable to attend the public hearing may send written comments to Village of Pecos, P.O. El objetivo de esta audiencia publica sera para recibir comentarios del publico sobre las necesidades de desarrollo de la comunidad y sugerencia para proyectos furtoros de CDBG para 2020.

El Programa de Subsidios en Bloque de Desarrollo Comunitario (CDBG) fue establecido bajo el Titulo I de la Ley de Vivienda & Desarrollo Comunitario de 1974, segun enmendado, para ayudar a las comunidades a proporciconar instalaciones comunitarias esenciales, proporcionar viviendas dignas para residentes, promover el desarrollo economico y en mantener un ambiente de vida adecuado. Los objetivos estatales y nacionales del programa CDBG requieren que la asistencia este disponible para las actividades que abordan al menos uno de los siguientes : 1.) Una actividad identificada como que beneficia principalmenta a personas de bajos y moderados ingresos. 2.) Ayuda en la prevencion y eliminacion de tugurios. 3.) Sstisfacer otras necesidades de desarrollo comunitario de origen reciente con una urgencia particular porque las condiciones existentes representan una amenaza grave e inmediata para la salud y el bienestar de comunicad donde otros recurso financiero no estan disponibles para sastifacer tales necesidades.

Las solicitudes estan limitadas a un monto maximo de \$750,000, excepto para las aplicaciones de planificacion que tienen un limete de \$50,000. Las actividades y categorias elegibles seran descritas.

Todas las partes interesadas estan invitadas a asistir, enviar ideas de proyectos, proporcionar datos de apoyo y testimonios, y otra informacion pertinente.
